NCBC 2018: Conference Recap

From August 12 to August 15, over 600 Clerk's Office staff members from bankruptcy courts across the country assembled in New York City, New York to attend the 38th annual meeting of the National Conference of Bankruptcy Clerks (NCBC). After several months of planning by the host court, the United States Bankruptcy Court for the Southern District of New York, led by Clerk of Court Vito Genna, attendees were treated to an exciting and eventful week that included a wide variety of educational opportunities, networking events, and a chance to learn about and explore the "Big Apple."

The Sunday before the first official day of the conference gave attendees a chance to pick up their conference materials and get settled into the conference hotel, the New York Marriott Marquis located in the heart of New York City's famous Times Square. Students enrolled in the Michigan State University (MSU) Judicial Administration Program enjoyed a full day of educational courses while the NCBC Board held their pre-conference meeting in preparation for the week's events and activities. Attendees gathered in the evening for a welcome reception at the beautiful Alexander Hamilton Custom House, home of the Southern District of New York.

The first full day of the conference featured an opening ceremony and welcoming remarks from M. Regina Thomas, NCBC President, Vito Genna, Clerk of Court, and the Hon. Cecelia Morris, Chief Judge for the United States Bankruptcy Court for the Southern District of New York. Lee Ann Bennett, Deputy Director for the Administrative Office of the U.S. Courts and the Hon. Karen E. Schreier, Judicial Conference Committee Chair for the Committee of the Administration of the Bankruptcy System delivered updates and words of appreciation.

The afternoon plenary session was facilitated by The Water Coolers, an NYC-based comedy group who gave a Broadway-worthy presentation, complete with songs and dances relating to various workplace scenarios and how we as Court employees can overcome difficult situations on the job.

Following the opening session, and throughout the conference, attendees were offered a variety of educational breakout sessions. The various breakout sessions offered throughout the conference included such topics as planning for a successful judiciary retirement, planning your judiciary career, presentation lessons from the Broadway stage, transitioning to Office 365, cybersecurity, hot HR topics affecting the courts, national IT initiatives, respect in the workplace, and more. This year's conference once again featured the annual Information Sharing Session, where exhibitors from the AO, FJC, NCBC, and local courts brought new programs, applications, and other innovations to share. Special thanks to everyone who participated for showcasing your work and talents!

On August 14, conference attendees were addressed by Associate Directors James R. Baugher, Mary Louise Mitterhoff, and Joseph R. Peters from the Administrative Office of the United States Courts and Education Division Director, Dana K. Chipman from the Federal Judicial Center. Each speaker spoke glowingly about the work being done by the courts and by all the talented individuals in the bankruptcy community.
